

CITIZEN'S CHARTER

BACKGROUND

This chapter presents a background to the business operations, segments, set-up and human resource of HPL.

Hindustan Prefab Limited was set up as a Deptt. in the year 1948 at Jangpura, New Delhi -110 014 on a plot of land measuring 28.639 acres primarily to manufacture prefabricated houses for the displaced persons from West Pakistan (now Pakistan). Later on the company diversified its activities into pre-stressed concrete electric poles and PRC railway sleepers for Railway. It was converted into private company in 1953 and established as a PSU in 1955 under the Ministry of Housing & Urban Poverty Alleviation.

In 1978, name of the company was changed from Hindustan Housing Factory Limited to Hindustan Prefab Limited having its registered office at Jangpura, New Delhi – 110 014.

Further the company has now diversified its activities and has secured orders for Project Management Services from Governments / PSUs / Autonomous bodies and is mainly working as Executing Agency.

HPL an ISO:9001:2008 Certified Company has its registered office at Jangpura, New Delhi and operates across the country within the jurisdiction of five Regional Offices and undertakes projects on turnkey basis from concept to completion besides assuring quality and timely completion.

HPL factory set up to manufacture pre-stressed concrete electric poles and PRC railway sleepers for Railways is located at Jangpura, New Delhi. Its plants and machineries are obsolete and company does not have viable orders in hand, therefore, manufacturing activities in the factory have been suspended since September 2004.

In the factory, there is material testing laboratory facility also for testing of raw materials and ingredients for manufacturing of concrete products. The company follows a quality policy for sourcing of various materials.
